## 8) Erection of new fingerposts

#### 9) Burwash Car Park

As part of Rother District Councils 'Devolution of Assets' the Parish Council has been offered to take over the maintenance and management of the car park next to The Bear pub along with the leasehold of the two black huts and the public conveniences.

**RESOLVED** – This item was amended by the Clerk for councillors:

Councillors review the documentation received and give their feedback and questions/ideas to the Clerk a minimum of two weeks before the June meeting. Councillors will earmark £500 for funding for an initial meeting with a solicitor for them to give advice to the questions raised and provide advice on areas to address with Rother and further questions to ask. The Clerk will speak to other Clerks who have taken on their Parish car parks for advice and information and continue obtaining information from Rother for councillors.

#### 10) Co-Option Process

Councillors discussed the process for interviewing the candidates. Co-option to take place at the May AGM as resolved in April full council.

**RESOLVED** – Councillors agreed the following for the co-option process:

- Potential candidate(s) at the agreed full council meeting will give a few minutes talk on why they would like to be co-opted onto the council
- Councillors will then ask candidate(s) questions
- Councillors will then vote on each candidate. Candidate(s) will have the option to leave the meeting at this point and the Chairman will read out the result of the vote. Candidates will only be successful if they receive a majority vote of councillors present. If this does not happen the position will remain vacant.
- If the candidate(s) is/are not in the room the Chairman will come out and let them know the result(s).

**RESOLVED** – Councillors voted on a paper ballot vote at the AGM.
