#### 4. Rural Cuts

Sylvie had been part of a group who had met ESCC to discuss the Willingford Lane verges. It was unclear which verges were managed by Rother and which verges were managed by local people. ESCC are going to provide her with a detailed map of the parish and which verges they look after. Also, as Lindsay was unable to attend the meeting, it was felt it would be better to get the information and to discuss it in more detail at the next meeting.

ACTIONS: Julian will check the details of the rural cuts with Emma.

#### 5. Allotments

Julian had heard back from Franchise, unfortunately, they rent some spaces to a few neighbours on the farm, but they aren't able to offer any more spaces to the Parish Council. Some other options include:

- Brooks Marle on Ham Lane ask Emma
- Burnt House Farm, although we need to check with Rother as there is an enforcement issue
- Mottynsden

ACTIONS: Julian will check with Emma about Brooks Marle and will liaise with Rother and David Vereker

## 6. Community Transport

There has been no response from Age Concern Heathfield nor fromBattle Community Transport. It was suggested that we could discuss with neighbouring parish councils eg Stonegate, Brightling and Dallington to see whether they would be interested in working together to apply for a grant for a shared minibus which each parish could use a day a week.

ACTION: Julian to contact neighbouring councils to see whether they were interested in working together to apply for funding.

## 7. Liaising with neighbouring Councils

Julian and Antonia have been in touch with Brightling and Dallington to discuss sharing environmental issues moving forward.

# 8. Grants for biodiversity audits and climate change infrastructure

There were no specific ideas for funding, but the group discussed the footpaths in Burwash High Street which are uneven and dangerous. Colin would like to show Highways the specific areas of danger. It was also suggested that we look at ways of returning the pavements that had been tarmacked over to the original brick pavements. Colin also gave an update on the lime trees and Julian will put him in touch with Cllr Amy Mack who would like to help with the lime tree work.

ACTIONS: Julian to put Colin in touch with Amy for lime tree work and to ask Emma if she could arrange for Darren from Highways to meet with Colin to discuss the pavements.
