# 3. Minutes from the previous meeting held on 6th December 2021.

The minutes of the meeting held on 6<sup>th</sup> December 2021 were agreed and will be submitted to Full Council on 11<sup>th</sup> January 2022.

# 4. Burwash Common and Weald Speed Limit.

Cllr. Franklin advised the members that he had received the following update from the Clerk:

- a. Confirmation that there are 2 routes to getting the work done: 1). Community Match Funding 2). Section 278
- b. Principle agreement between Costain (who run the commercial side of highways) and the team run by Brian Banks (ESCC) that we can go ahead through section 278.
- c. Work to be carried out by Jacobs.
- d. Title of the work will be 'Additional Business' if we go down the section 278 route.
- e. If we go down the section 278 route BPC will be responsible (as known) for the maintenance. Confirmed with Peter Heasman that this will be minimal, probably confined to theft of signs or damage to signs. Longer term replacement could be needed.
- f. Confirmed with our insurers that we are covered if we go down the section 278 route for any damage or theft of signs.
- g. Quote is being pulled together, Pete waiting on a number of other departments but is chasing them.
- h. Once quote sent through and agreed then stakeholders will be consulted, and design pulled together and date for works can be determined.
